CGS 289 CT: Everyone Connected

Vision

The State of Connecticut defines “Digital Equity” as “a condition in which all individuals and communities have the information technology capacity needed for participation in society, democracy, and the economy of the state” (CGS § 289). The vision behind the plan, “Connecticut: Everyone Connected,” defines the resources, challenges, and path forward to making sure all residents can flourish in a society that depends ever more on access to digital tools and the skills to use them.

Background

With support from the Federal Infrastructure Investment and Jobs Act, the Commission for Educational Technology completed a multi-year effort to design and implement a statewide Digital Equity Plan. **The goal of the plan is to help ensure that all residents have access to and can utilize technology for learning, career advancement, leveraging state services, health and wellness, and overall participation in society.**



CT Digital Equity Program

CGS 289 CT: Everyone Connected

Covered Populations:

- Those living at or below 150% of the federal poverty line
- Aging Individuals
- People incarcerated in State correctional facilities
- Veterans
- Individual with disabilities
- People with a language barrier (English learners and those with low literacy levels)
- Members of a racial or ethnic minority group
- Residents who reside in rural areas

Plan addresses Availability; Digital Literacy; Technical Support and Access to Public Resources and Services

Expected Outcomes:

- **Economic and Workforce Development**
- **Education**
- Health
- **Civic and social engagement**
- Delivery of essential services



Digital Equity Act Overview

FUNDED BY THE BIPARTISAN INFRASTRUCTURE ACT

Infrastructure Investment and Jobs Act: 65B

Programs:

- ✓ Digital Equity Act - \$2.7B
- ✓ Broadband Equity Access and Deployment Program \$42.5B
- ✓ Affordable Connectivity Program \$14.2B
- ✓ Tribal Connectivity Program \$2B
- ✓ Middle Mile Connectivity - \$1B
- ✓ Digital Discrimination Section



Digital Equity Act

Eligible Administering Entities:

- The State, a Political Subdivision of the State, an Indian Tribe, a Native Hawaiian organization
- A Foundation, Corporation, Institution, Association, or Coalition that is – (i) not-for-profit, (ii) providing services in the state and (iii) not a school
- A Community Anchor Institution, other than a school
- A local Educational Agency
- An Entity that carries out a Workforce Development Program
- An Agency of the State that is responsible for administering or supervising adult education and literacy activities in the state
- A Public or Multi-Family Housing Authority
- A partnership between any of the preceding entities



CT Digital Equity Program Goals

Key Initiatives:

1. Promote Development of Digital Skills and Technical Support Programs
2. Increase Public Awareness of Digital Equity Resources
3. Ensure Residents Have Affordable Options for Getting Online that Meet Their Needs
4. Support Development of Accessible and Inclusive Digital Government at the State and Local Levels
5. Support High-Speed Broadband Infrastructure build out
6. Foster Ongoing Learning About Digital Equity Best Practices

The HNXT Next History Project goal is to capture the history of Hartford Next which will be used to educate NRZ members and the community at large about our organization. The output will be used for education and marketing, and to facilitate better understanding of the role of HNEXT, expanded collaborations and partnership opportunities.
