



#### Carey Shea

Carey Shea was most recently the Interim Executive Director of the Hartford Land Bank. She has worked in community development for four decades in the areas of affordable housing development, disaster recovery, community revitalization philanthropy, federal housing policy, community organizing and sweat-equity housing. She is a resident of Hartford where she is a community activist and co-founder of the Friends of Zion Hill Cemetery.







#### Randal Davis, Deputy Dir. of Development Services

This City Department oversees Economic Development, Planning, Housing, Small Business
Development, Licensing and Inspections and Blight Remediation Programs. Mr. Davis brings 10
years of experience in Strategic Planning, Communications and Policy Analysis & Development
within the public sector, along with 20 years of experience in Law, Higher Education and the
private sector to his role.

At CTDOT, Davis was a key figure in the team responsible for launching Connecticut's first Bus Rapid Transit System (CTfastrak), and one of the lead corporate, government and community liaisons at the Connecticut Department of Transportation. He worked closely with the I-84 Viaduct Project Team in Transit Strategy Development, Program and Resource Planning and Public Communications and Community Engagement.

Randal was born in Hartford and raised in Bloomfield, Hartford and Windsor, CT. He has lived in San Francisco and New York City, where he worked for major national and multinational corporations as well as an institution of higher education in the areas of marketing, administration and compliance. He studied Liberal Arts at New School University, New York, NY and received his Juris Doctorate in Law at Rutgers School of Law – Newark, NJ, where he focused on Administrative Law, Public Governance and State & Federal Regulatory Oversight and Compliance. He is licensed to practice law in CT and NY.




#### I. Charles Mathews, Dir. of Development Services

Mr. Mathews grew up on the streets of Boston. A former high school dropout; a former member of the United States Marine Corp; and for many years worked as a sheet metal mechanic. He received his GED from the State of North Carolina; his Associate in Arts degree with honors from Greater Hartford Community College; his Bachelor of Arts degree, with honors, from Wesleyan University; and his Doctor of Law degree from Cornell University School of Law.

Since graduating from Law school, Mr. Mathews has spent his time as Special Counsel to the House of Representatives Congressional Committee investigating the assassinations of Dr. Martin Luther King, Jr. and President John F. Kennedy. He served as a senior executive at a number of fortune 100 corporations; worked and served in City and State wide political systems and engaged in numerous efforts and activities with non-profits and other community organizations to support individuals and programs in underserved neighborhoods and communities.

He is passionate on issues of youth development, second chance educational opportunities and equal justice and opportunities for all. He is the Former President of the Wilson Gray YMCA Youth and Family Center Board of Directors, Former Chairperson of the Hartford Stadium Authority, Former Member of the Greater Hartford YMCA Board of Directors and Former Member of the Hartford Foundation for Public Giving Board of Directors.

- Project & Contract management of City assisted development projects including brownfield redevelopment.

# THE BUSINESS ATTRACTION, STRATEGY & POLICYTEAM

- Manages city assigned projects by way of tax fixing agreements, etc.
- Works with the Planning Division and strategic planning for fostering growth across the City
- Explores, recommends and manages policy related issues and concerns such as community benefit agreements associated with all city assisted projects
- Coordinates with partner organizations to support initiatives such as business attraction, workforce development, business assistance programs, etc.







## Dr. Elda Sinani LL.M, Dir. of Licenses & Inspections

**Dr. Elda Sinani, LL.M**. is the Director of Licenses & Inspections for the City of Hartford, becoming the first woman in the 200+ years to hold this position. Her main goal is to reintegrate online permitting, inspection process and all code violations to provide better service, increasing efficiency and revenues. Dr. Sinani has 20+ years experience in the legal field, public service, academia and government service. Previously she was the Operations Director of the Department of Development Services where she managed successfully a multi-million dollar operation budget, multiple contracts and human resources program which resulted in cost reductions, revenue improvement, and team building.

In addition to her law degree from Albania, Dr. Sinani holds a Law Degree from the University of Connecticut School of Law, and a Doctorate in Law and Public Policy from Northeastern University. She is very proud of her Albanian heritage and organized the City's and State's first official Albanian Independence Day in November, 2007. Dr. Sinani is the author of several reports and articles on human rights, racial and gender discrimination, and immigration issues. Her name was added to the Wall of Tolerance in Montgomery, Alabama to provide inspiration to all those who chose to stand up against hatred and racial discrimination.

Dr. Sinani is Visiting Assistant Professor of Public Policy at Trinity College, currently teaching a graduate course in Budget Management & Public Policy. As a public policy professor, her primary goal is to empower students to become the next generation of public sector leaders by helping them develop their intellectual skills, and understand that knowledge itself is not given; rather, it is constructed by individual experiences and interactions within a social and cultural environment. She encourages her students to embrace their critical and independent thinking through theory and practice.



#### LICENSES AND INSPECTIONS

• The Licenses & Inspections (L&I) Division champions building safety in Hartford, by enforcing compliance with city, state and international building codes governing construction, new buildings, and existing structures.

#### **VISION**

- To build and sustain a safer Hartford through building code enforcement.
- During the Fiscal Year 2021, L &I Division has issued more than 4,095 permits and conducted over 14,000 inspections with cost valuations of projects constructed at \$330+ million dollar construction value by adding over \$8.4 million dollars to the City Revenue.



Service	Goal
Leadership and Management	Ensure that the L&I Program is run in a fiscally accountable manner, and implement new initiatives to increase the revenues in the department. Create and maintain a professional, diverse and responsive workforce in the L&I Division. Implement policies, ordinances, and measures, to operate more efficiently.
Licensing	Assure the City's residents and visitors that certain businesses are certified to operate in compliance within applicable health, safety and business operation regulations by providing licenses to those businesses, issuing vending identifications and parking permits for food and merchandise vendors, and issuing permits for commercial parking lots.
Building and Trades	Review building permit applications and plans for code compliance, issue building permits, and conduct ongoing building inspections to assist and ensure that property owners and contractors build and repair housing, industrial, and commercial structures in compliance with applicable building codes.
Weights and Measures	Ensure that City residents and visitors receive the quality and quantity of goods and services they purchase.





#### REVENUE



- 41% Increase in L&I Revenue from FY20 to FY21
- 55.5% Increase in L&I Revenue from FY18 to FY21
- FY22 L&I Revenue Totals (July 1, 2021 to December 31,2021) are at 37.8% of FY21 Revenue Totals


#### PERMIT ACTIVITY



The total number of permits issued during FY-21 has increased slightly. The variance expressed in the data between FY-20 and FY-21 to some extent can be related to the measures taken as a result of the COVID-19 outbreak, which restructured how permit application intake was practiced.

- 4.4% Increase in Permit Applications Received from FY18 to FY21
- 3.4% Increase in Permits Issued from FY20 to FY21
- Permits issued for FY-22 currently stand at 54% of FY-21 Totals
- Despite the current economic and public health crises, among all of the above data sets, FY-22 is exceeding the rate of intake for the outlined parameters compared to previous fiscal years. This will increase significantly with the launch of Accela, which will enhance and expedite the intake process.

#### INSPECTION ACTIVITY




Violation notices issued have declined in recent years. As with other parameters observed, it is likely that these numbers were impacted to some extent by the pandemic, as year-over-year, quarter four numbers fell almost universally.

Despite this, the number of inspections performed has increased significantly. Year over year the number has increased in part due to projects related to fully closing out permits from previous fiscal years.

- FY22 Notices of Violations are currently total 62.7% of FY21 totals
- Inspections performed in FY-22 are sitting at 36% of FY-21 totals.
- Despite the current economic and public health crises, among all of the above data sets, FY-22 is exceeding the rate of intake for the outlined parameters compared to previous fiscal years. This will increase significantly with the launch of Accela, which will enhance and expedite the intake process.

#### LICENSING ACTIVITY



Significant drop in number of Vendor's Licenses, and Extended Hours Licenses issued during Fiscal Year 2021, due to


- Slowdown as result of COVID-19, and
- Deleterious effect of current economic crisis on small businesses.

#### Results:

- 64.9% Decrease in Vendor Licenses
   Issued from FY20 to FY21
- 25% Decrease in Extended Hours Licenses Issued from FY20 to FY21
- FY22 Vendor Licenses Issued stand at 274% of FY21

Fourth quarter numbers fell significantly, year-over-year.

#### WEIGHTS AND MEASURES ACTIVITY



- 72.7% Increase in Site Inspections
   Conducted from FY20 to FY21
- 90.5% Increase in Seals Issued from FY20 to FY21
- 318% Increase in Meters and Devices
   Inspected from FY20 to FY21
- FY22 Site Inspections are being completed at a higher rate than previous fiscal years.

#### L&I REPORT GLOSSARY

- PLAN REVIEWS The review of construction documents prior to the start of construction.
- PERMITS Authorization to renovate, and/or build new
- CONSTRUCTION. Authorization to occupy a dwelling.
- APPLICATIONS RECEIVED Documents submitted by customers for the purpose of receiving authorization from L&I (Examples of L&I Applications: Building, Electrical, Demolition, Mechanical, and Plumbing)
- LICENSE Authorization to operate a business in the City of Hartford (Examples: Food Vendor, Designated Vendor, etc.)

- B&T INSPECTORS Inspectors that perform field inspections of construction projects and emergency structural safety inspections.
- WEIGHTS & MEASURES Tests weighing and measuring devices, inspects packaging, ensure compliance with state and local regulations.
- NOTICES OF VIOLATIONS ISSUED Number of letters mailed to the home owner listing sections in the municipal code that are noncompliant.
