Violette Haldane presented the Treasurer's report. We still wish to close down one of the two bank accounts but will not do so right now. We are expecting funds from an economic development grant that are direct deposited into an account that we will keep open until those funds are received. We are expecting about \$20,000, less legal fees, from the state. The legal fees are for attorney's contracted with by DECD. Concern was expressed regarding the requirement of HNXT to pay the State's legal fees.

The Love Your Block grant is a little different this year. There are now two tiers for this grant, one at \$2,500 and the other at \$25,000. The due date for applying is soon — March 8. There is also a neighborhood beautification grant from the Hartford Foundation and an AARP livable community grant. Both of these grants have a short turnaround time. There is a March 22 deadline for the AARP application. And the project must be completed by the end of the summer. There was a session on grants today that Marion attended and she has power points available to share. There were two cities showcased. One was for the West Hartford initiative in blocking off portions of the central streets so that restaurants could have outdoor dining during the pandemic. Another one was for improvements in marking some of the Hartford streets near the South Green. The AARP grant is for anything that impacts senior citizen — parks or anything. Average grant from AARP is \$11,000 or \$12,000, but it can go up to \$50,000. Marion will send a copy of the power point out to everyone.

Elizabeth Davis said that the Communications and Marketing Committee is working on our website and also getting the information poster out. They are not ready to set up the donation button on the website but are still getting helps and hints from such organizations as the Hartford Public Library. There will be more information on this for the next meeting.

Mary Falvey gave a shout-out to Robin Zaleski who has agreed to take charge of our Facebook page. Everyone should hop on to the page and give it a "Like." If you have an NRZ Facebook page you can share it and you can share a post from the Hartford Next page onto your own page. If you don't know how to do these things, ask Robin. We want every Hartford person to be an ambassador and booster of Hartford Next and the NRZ's.

Jeff Stewart reported from the Governance Committee that there are some changes needed in the by-laws including a name change from Hartford 2000. The UCONN Urban Legal Initiative, Inc. (CULI) is helping out with this. If there is anyone out there who can join committees, it would be helpful. Let us know. Associate members cannot vote but they also do not have to commit to making every meeting, they just need to help out. As far as volunteer recruitment goes, there is an application so that we have some help in match up a volunteer's skills with our needs.

The Saturday, February 19th, webinar features Health and Human Services and the Department of Public Works. join us on Saturday and learn more about what these departments do. There are also a number of maybe surprising aspects under the HHS purview;. Please share this information with your neighbors. The March 5 webinar is on Youth, Recreation & Education and will include Kim Oliver presenting from the Department of Families, Children, Youth and Recreation. The March 19 webinar will be on Police, Fire & Emergency Services.

AmeriCorps Service Member. HNXT has selected is a UConn School of Social Work student as the LISC AmeriCorps service member to join Hartford NEXT with at start date of March 1st.

2022 is the **25th anniversary of Hartford NEXT** (formerly Hartford 2000). If you have ideas on how to celebrate our 25th anniversary, let us know.

NRZ Funds. The \$50,000 grant from the City of Hartford has been received and distribution to the NRZ's by HNXT will begin. NRZs, following City of Hartford confirmation of NRZ's compliance with the NRZ ordinance should submit their community engagement expenses for reimbursement. This benefit is for expenditures between July 1, 2021 through June 30, 2022. HNXT has received \$5,000 for managing the NRZ funding process for the City of Hartford.

There was a question regarding what will happen to left over funds. The response, If an NRZ decides not to participate or does not spend all the funds within the allotted time, this may be interpreted as an indication that NRZ's do not need or want funds. This is certainly not so and we don't want to send that message. There is some guidance on "leftover" money and, when we have more details it will be discussed.

There was also a question about how the funds are meant to be spent by the NRZ's; this funding was set aside for community engagement in each of the NRZ's. This includes such things as sending out notices, zoom accounts, etc.; anything that is going to enhance community engagement.

Notes:. Lindsay Ewing reported the **West End Civic Association** raised \$1,500 for Interval House to assist with the resettlement of the Afghan family that the West End is welcoming. Those families who arrived last year are settling in well; they have jobs and are learning English. This has been a successful effort. N-95 masks have been distributed via neighborhood social institutions and food pantries. There is a blood drive at the Noah Webster

Robin Zaleski, Chair of the **South Downtown NRZ**, reported that they are applying for one of the Hartford Foundation grants, teaming up with the Center for Latino Progress, the Knox Foundation, and the Institute for Hispanic Families (part of Catholic Charities). The goal is to create a public orchard with shade trees and fruit trees near 55 Elm Street, right across from the Pump House at Bushnell Park. Also, there is an application for a zoning change at city Planning & Zoning to redevelop into apartment buildings where there is now surface parking.

Jackie McKinney and David McDonald reported that the **Asylum Hill Neighborhood Association** is awaiting receipt from the city and the state of the final approval of their updated strategic plan. They are planning an event, chaired by Ted Carroll, for June 26.

David Morin from Parkville NRZ reported that they just voted for a letter of support for \$50 million for the Parkville arts and innovation grant. The application shows the community benefits and environmental justice benefits of the project. This grant must be matched 4 to 1 by the developers and has to be submitted with details in a short time frame. There are quite a few projects that are shovel ready. We need to support the city of Hartford's efforts to get this grant. Randal Davis, City of Hartford Dept of DDS remarked that it is an innovation grant and that Parkville is a transformative area. So, it's a natural place for which to submit a grant. There are multiple players involved; there's an economic development team because realizing the vision will be a heavy lift. There is a very short turnaround time, so they hired a consultant because this is a big opportunity. One of the big things about this grant is that the projects must be shovel ready. But this meets the reality in Parkville, because work is getting done already and the developers are already involved. "We are ready and poised for this undertaking. Many thanks to DDS for their help." He added that Parkville NRZ is not a 501(c)(3); they don't need to be because they do a lot of collaboration.

Mary Falvey reported that the **Hartford Preservation Alliance** released their list of most threatened buildings on Valentine's Day. HPA received a great response from various neighborhoods, including in Clay-Arsenal, Barry Square (the 20 Clifford Street old St. Augustine's School), and Parkville (152 and 154 Francis Street). There will be two public meetings next week. Planning & Zoning is at 6 pm on Tuesday and their agenda includes an application for a food truck park at 510 Farmington Avenue. This food truck park is a wonderful use of vacant space in the neighborhood. And at 7 pm The Common Council will consider the mayor's resolution of 16 properties going to Hartford Land Bank.

Eileen Noonan reported that **Southwest/Behind the Rocks NRZ** is involved in the work on the South Branch of the Park River trail. Many participants spoke up and remarked that the various branches of the Park River go through several NRZ's so there is strength in numbers by combining with Parkville, Asylum Hill, and West End NRZ's and getting in touch with Mary Pelletier who has also worked on Park River projects.

At-Large Board Member Jeff Stewart reported that the DEEP will be resuming water activities at **Keney Park**; boating and other activities will be starting up when the weather permits. DPW is looking at what capital improvements are needed in that park.

City of Hartford Board Member Randall Davis (DD) reported that there will be a presentation to the council about all the initiatives underway under the aegis of DDS. There will also be a presentation to the Blue Hills NRZ on March 7. People should know that DDS is short-handed; there are staff 22 vacancies right now.

Robin Zaleski mentioned that the post office has a program that allows us to mail postcards to every address, residential or business, along a postal route. This makes it unnecessary to purchase a mailing list.

We also welcomed one of our two newest NRZ leaders. Keisha Dickenson, the **new Chair of the Upper Albany NRZ**. There is a wealth of information among participants in this meeting and newcomers should not hesitate to reach out to other NRZ leaders.

A guest provided information on experiences at Hartford Public Library. The HPL representative indicated that the information would be shared with the Library.

A guest requested the how to obtain information on all the activities taking place in Hartford. It was suggested that they sign up for the Office of Community Engagement's newsletter which is issued each Monday.
